- Mark Hughes discussed a "Master Plan" for TCC trail needed for culverts (find and assess), 3 rail road bridges and gravel needed.
- We need to rent the reclaimer from the TCC to use on the TCC. Matt Hughes suggested that we check with TCC to see if we get extra money for having to use their reclaimer.

# NTA

Discussion of maps and businesses having a bad season. One club suggested that we reclaim all maps back and give them out next year. There are several of our establishments have given out many maps and we do not have many left. Another club wants to do the map project every other year. So, businesses would need to pay about \$250 every other year instead of \$125 yearly. What about the businesses that want to get on the map in between years? Discussion of this is the money maker for NTA to cover their expenses for insurance, sending Director and Rep to meetings, sending Youth Rep (when we have one) to meetings, and representatives to WATVA meetings. At NTA there was discussion that ultimately the map would be discontinued due to GPS on the newer sleds. Our recommendation to NTA: Leave well enough alone!
