Groomer Trails:

- Brushing Wild Rivers Trail is about ¾ done and about ½ picked up.
 Tri-County Corridor Brian Christianson used the reclaimer. Cliff has been mowing.
 The mower will then go to Trail 27 after Tri-County Corridor (may not be able to move in BRSF due to Oak Wilt Al Makela will check)
 In the area of Motts Ravine Road, there has been a controlled burn, it may be possible to do grading with the box grader
- Matt Hughes brought up our accounts what is left and what we plan to do to use up the accounts.
- Bridge inspections: We have 4 bridges: Blueberry (railing needs fixing), Poplar, Hughes and Lindahl
- Tri-County Corridor culvert and bridge update: We have 2 bids for work to repair the
 bridges, with the promise of another bid coming in. Discussion of railing height.
 Al Makela has received some signs from Patrick and will get them to Dave Whitehead.
 Brian Christianson and Bruce Bergsten will check the TCC for sign order. All advertising
 signs need to be taken off the TCC.
- BRSF discussion of a sign order.
 Mark Hughes has about 50 posts and Bruce Bergsten has about 20.
- Landowners easements for Trail 6 are needed.
- Beavers = grates re on the culverts on Trail 6. WRT culverts have been cleaned out.
- Clint's suggestion to move Trail 235 Al Makela met with Clint to discuss moving the trail.
 We want to keep the trail as is. Douglas County has now received property back and can get a trail into Superior.
- Matt Hughes brought up that the bridge over Sandy Run is being replaced. It is probably too late, but we should contact Dan Gepart to see if our trail can be included in the new bridge vs. going up and down the hillside.
